

Anent to the above subject, many employees have opted for higher EPS'95 pension and recoveries were made accordingly and remitted to RPFC's office. However, some of the applications for higher pension were rejected by RPFC-I and consequently we have restricted the recovery of FPS contribution to a Salary (Pay+DA) not exceeding Rs.15000/- per month with effect from 01.09.2014, in respect of those employees whose Higher Option was rejected by RPFC-I. Some of the retired employees who opted for higher EPS pension are also drawing lower pension only.

The Regional Provident Fund Commissioner, Hyderabad vide reference cited, stated that the excess amount of EPS contribution made by the employees will be refunded and advised Corporation to send individual employee claim for arranging refund of the excess EPS contribution lying in RPFC account.

In view of the above, all Unit Officers are requested to obtain and forward to this Office, individual applications in the format enclosed from employees/retired employees, in order to claim refund of excess remitted amount, from PF Office and deposit the same in employees PF account, at the earliest.
